

A Auditor's report with a qualified opinion due to a material departure from generally accepted accounting principles

(financial statements, Part 9 of Book 2 of the Netherlands Civil Code)

AUDITOR'S REPORT

Report on the financial statements¹

We have audited the accompanying² financial statements XXXX³ of ... (name), ... (statutory seat), which comprise the balance sheet as at ..., XXXX, the profit and loss account for the year then ended and the notes⁴.

Management's responsibility

Management⁵ is responsible for the preparation and fair presentation of the financial statements and for the preparation of the management board report⁶, both in accordance with Part 9 of Book 2 of the Netherlands Civil Code⁷. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's responsibility

Our responsibility is to express an opinion on the financial statements based on our audit. We conducted our audit in accordance with Dutch law. This law requires that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control⁸. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

Basis for qualified opinion

The company's inventories are carried in the balance sheet at € We do not agree with management regarding the amounts at which the inventories are stated. Management has not stated the inventories at the lower of cost and realizable value but has stated them solely at cost, which constitutes a departure from Part 9 of Book 2 of the Netherlands Civil Code. The company's records indicate that had management stated the inventories at the lower of cost and realizable value, an amount of € ... would have been required to write the inventories down to their realizable value. Accordingly, cost of sales would have been increased by € ..., and income tax, net income and shareholders' equity would have been reduced by € ..., € ... and € ..., respectively.

Qualified opinion

In our opinion, except for the effect of the matter described in the Basis for qualified opinion paragraph, the financial statements give a true and fair view of the financial position of ...
